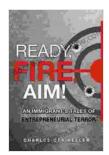

We can only stop these criminals if we work together.

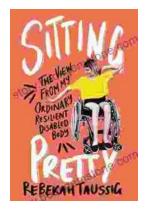

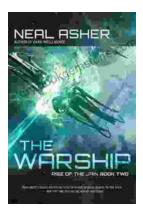
